

## WASHINGTON TOWNSHIP COUNCIL MEETING – FEBRUARY 21, 2012

**CALL TO ORDER** Mayor Feikles and Vice-Mayor Glass were absent; Mayor Feikles appointed Councilman Patterson to oversee this meeting. Councilman Patterson called the Washington Township Council Meeting to order on February 21, 2012 at 4:00 P.M. at the Washington Township Administration Building at 11800 Edinboro Road, Edinboro, PA 16412. Those present were Councilwoman Campbell and Councilman Pernisek. Also present were Manager Anthony, Community Development Specialist Deborah Anthony and Zoning Administrator Carcella. There were no Visitors.

**AGENDA** It was voted on motion by Campbell, seconded by Pernisek, to approve the Agenda as presented.

**APPROVAL** Motion carried unanimously.

**COUNCIL MINUTES** It was voted on motion by Pernisek, seconded by Campbell, to approve the Council Minutes of February 21, 2012. Motion carried unanimously.

**TREASURER'S REPORT** The following checks presented for approval: General Fund #13955-13957, Sewer Fund #6246 and manual check #6209, and payroll checks #10000201, #995948-995952. It was voted on motion by Campbell, seconded by Pernisek, to approve all the checks as presented. Motion carried unanimously.

**SECRETARY'S REPORT** Manager Anthony gave a verbal report on repairs to the International 5500 truck were \$3,300.00; the Road Crew is installing new signs and posts that were recently purchased in the amount of \$1,800.00; the power washer civil suit that the Township sold to a party in central PA has been settled in favor of Washington Township but the purchaser has no material assets available to be sold for the settlement; a file; and a disposition list will be forthcoming at a future meeting for Council's review. It was voted on motion by Pernisek, seconded by Campbell, to re-list the power washer for sale on Muncibid. Motion carried unanimously.

**CORRESPONDENCE** Manager Anthony presented the following correspondence: a letter from Erie County Planning concerning the 2040 Long-Range Plan and a letter from Central Erie County Paramedics requesting authorization to purchase fuel for their equipment vehicles. It was voted on motion by Patterson, seconded by Pernisek, to deny the Paramedics request as presented. Motion carried unanimously.

**ZONING OFFICER'S REPORT** Zoning Officer Carcella had no Subdivisions to report, but presented the Enforcement Report, concerning a complaint from Willey's Mobile Home Park and a R-O-W encroachment on Silverthorn Road. The Porto block building on Edinboro Road was deemed a nuisance; appropriate action to be taken by March 12, 2012 if this building is not brought in to compliance with the Township Code.

**ENGINEER'S REPORT** Engineer Halmi was not present at this Meeting.
