WASHINGTON TOWNSHIP REORGANIZATIONAL MEETING - JANUARY 6, 2014

CALL TO Solicitor Burroughs called the Washington Township Council Reorganization Meeting to order on ORDER Tuesday, January 6, 2014 at 7:00 P.M. at the Washington Township Administration Building, 11800 Edinboro Road, Edinboro, PA 16412. Those present were Councilmen Patterson, Feikles, Pernisek, Glass, and Councilwoman Campbell, Engineer Halmi, Manager Anthony, Zoning Officer Willow and Community Development Specialist Deborah Anthony. Visitors present were Kathy Pernisek, Chris Roth, Kirk Dillen, and Bunny Bucho.

AGENDA It was voted on motion by Campbell, seconded by Glass, to approve the Reorganization Agenda. **APPROVAL** Motion carried unanimously.

APPOINT TEMPORARY CHAIR Solicitor Burroughs appointed Councilperson Mike Glass Temporary Chair.

- **ELECT MAYOR** Councilman Pernisek nominated Councilwoman Campbell as Mayor for 2014. **Voting for** Campbell were Pernisek, Glass, Feikles and Campbell. **Voting opposed** was Patterson. **Campbell was elected Mayor for 2014.**
- **ELECT VICE-MAYOR** Councilman Patterson nominated Councilman Glass as Vice-Mayor. Councilman Glass nominated Councilman Pernisek as Vice-Mayor for 2014. No other nominations were received. **Pernisek** was elected Vice-Mayor for 2014.
- APPOINT Mayor Campbell appointed David Anthony as Secretary/ Manager for Washington Township for SECRETARY/MGR 2014 at a rate agreed upon in his contract. <u>Anthony was appointed Secretary/</u>
 Treasurer/ Manager for 2014.
- **SET MEETING TIMES** It was voted on motion by Glass, seconded by Campbell, to set Council Meetings on the first Tuesday of every month at 7:00 P.M., to set the bi-monthly Meetings at 4:00 P.M. on the third Tuesday of every month except for May 20th which will be held on May 21st and November 4th which will be held on November 5th. Workshops will be on an as-needed basis on the fourth Wednesday of every month at 4:00 P.M. **Motion carried unanimously.** The 2015 Re-organizational Meeting will be on January 5, 2015 at 7:00 P.M.

APPOINT <u>It was voted</u> on motion by Glass, seconded by Pernisek, to appoint the Quinn Law Firm as the **SOLICITOR** Township Solicitor. <u>Motion carried unanimously.</u>

APPOINT It was voted on motion by Feikles, seconded by Glass, to appoint Deiss-Halmi Engineers as the ENGINEER Township Engineer. Motion carried unanimously.

STATE CONVENTION <u>It was voted</u> on motion by Feikles, second by Glass, to name Campbell as the voting delegate to the State Convention. **Motion carried unanimously.**

ALTERNATE DELEGATE It was voted on motion by Campbell, second by Glass, to name Feikles as the **STATE CONVENTION** alternate voting delegate to the State Convention. **Motion carried unanimously.**

RESOLUTION #3-14 FEE It was voted on motion by Patterson, seconded by Feikles, to approve Resolution **SCHEDULE** #3-14, the fee schedule for 2014. Motion carried unanimously.

APPOINT VACANCY CHAIRPERSON <u>It was voted</u> on motion by Glass, seconded by Pernisek, to appoint Anita Schrott as Vacancy Chairperson. <u>Motion carried unanimously.</u>

STREET LIGHT It was voted on motion by Feikles, seconded by Pernisek, to appoint Laurie Showman as **ASSESSMENT COLLECTOR** the Street Light Assessment Collector. Motion carried unanimously.

PERSONNEL COMMITTEE Mayor Campbell appointed Glass and Pernisek as Personnel Committee Representatives for 2014.

AUDIT COMMITTEE Mayor Campbell appointed Pernisek and herself to the Audit Committee for 2014.

EMA Mayor Campbell appointed Anthony and Patterson as Emergency Management Association representatives for 2014.
