ZONING OFFICER'S REPORT Zoning Officer Carcella presented the Enforcement Report, informing Council that Warning letters were sent out to residents concerning snowplowing across Township roads, I & I issues at Majestic Heights Mobile Home Park, and a property line issue concerning the sale of a home on Eureka Road. TAX COLL. CABLE RATES Manager Anthony presented a notice from Coaxial Cable that their rates will remain the same as 2011. No action was required.

WOODS DRAINAGE Manager Anthony presented a request from Wynn Woods concerning a drainage issue on **CONCERNS** his Water Street property. A lengthy discussion ensued concerning stormwater from Edinboro developments and their effect on Township residents. Council recommended that an open ditch be created rather than approving Wood's request for the pipe purchase, and also offering broken concrete from the Township to act as rip-rap and help with the drainage issue on Wood's private property.

VISITORS Bill Heald, the Washington Township Emergency Management Coordinator, and Bill Felege, the Emergency Management association President, addressed Council on Association's current program and their future plans. No action was required.
